Sample Successes with Abuse Assessments and Expert Witness

- Assisted the Federal Bureau of Investigations (FBI) in sending two Louisiana District Attorney (DA) employed prosecuting attorneys to be disbarred and sent to jail. I discovered their offenses and acquired the evidence that assisted in causing the FBI to open their investigation that freed thousands from undeserved charges.
- My testimony acquired supervised visitation and convictions when a psychologist was testifying that the child was safe with the sex offender. I challenged the Court to show how a two-year-old child could be safe with a sex offender when she admitted that he was a possible danger to himself and others. Yet, he could be trusted with a vulnerable child under the age of three. The Court ruled in favor of my statement over the psychologist's statement. The ruling led to the offender being convicted of domestic violence charges.
- I have testified and written complaints for numerous families whose children were being wrongly held by Child Protection Services. Today thousands of children's lives have been improved or saved per my assistance. Many of them have been returned to their parents.
- As a result of my investigation that revealed extreme abuse, I learned through communications with officials that the perpetrator was part of the leadership of the human trafficking ring. Many of those children are reaching safe homes today because I brought the case to the Department of Homeland Security (DHS). The child of the perpetrator is now safely with her safe parent.
- I assisted Senator Landreau in ensuring thousands of displaced families acquired homes and support after Hurricane Katrina.
- As part of my concerts to further independent artists' careers, many are enjoying thriving careers. Furthermore, many non-profit organizations that assist trauma survivors acquired needed
